

HERE IS HOW TO ELIMINATE TAXABLE INCOME ON IRA/401K

Mount Olive is excited to let you know that we have a new way to give gifts to the church **and** lower your taxable income.

If you are reaching the age of 73 in 2024 and are forced to take a Required Minimum Distribution out of your IRA or 401K, did you know you can gift it to your church and not have to claim it as taxable income?

An RMD is the smallest amount you must withdraw from your tax-deferred retirement accounts every year after a certain age. If you have put money into tax-deferred retirement accounts, such as Individual Retirement Accounts (IRAs) and 401(k) workplace retirement accounts, this means you postponed taxes on your contributions and earnings; you didn't eliminate them. Eventually, you must pay tax on your contributions and earnings. RMDs make sure that you do that UNLESS you direct it to a charitable organization like Mount Olive.

It's very simple. All you have to do is have your investment company write a check directly to Mt. Olive Lutheran Church or have them initiate a wire transfer directly to our bank. Your contribution will show up on your year-end statement as a non-deductible contribution, BUT you will NOT have to claim the donated amount on your income!!

If you reach age 72 in 2023, the required beginning date for your first RMD is April 1, 2025, for 2024.
